Background

Nicollet County is in the process of completing its redistricting plan as a result of the 2020 Census. The County Board is required by Minnesota Statutes 375.025 to conduct a public hearing before acting on the plan to redistrict. The purpose of this public hearing is to consider the plan for redistricting of county commissioner districts.

The board set April 19, 2022 as the date of the public hearing as well as the date to take action on the County's redistricting plan. The County's redistricting plan must be adopted no later than April 26.

Nicollet County Public Services conducted an Open House April 4, 2022 for the public to learn more about redistricting, review three redistricting options, and provide input on the county commissioner district plan. Additionally, the redistricting plan was available in the Public Services office for the public to review. No additional plans were submitted by the public and no public comments were received.

Recommended Board Action

At today's meeting, the County Board is recommended to complete a series of items:

- Conduct a Public Hearing to consider the plan for redistricting of county commissioner districts
- Approve a redistricting plan of county commissioner districts as a result of the 2020 Census.
- Establish an election cycle to comply with the term staggering requirements for county commissioner districts.

Following the County Board's actions, the Public Services Department will complete the steps necessary to record the board approved 2022 Nicollet County Commissioners Redistricting Plan with the Office of the Secretary of State and will complete any additional notification and administrative responsibilities.

REDISTRICTING NICOLLET COUNTY 2022 REDISTRICTING PLAN



Overview

Redistricting...

- Is the process of redrawing boundaries of election districts
- Is done every 10 years in conjunction with completion of the Census
- Starts at the federal level and works down to precincts (and then to polling places)
- Ensures people are equally represented: one person, one vote

Who is Involved...

- Legislature: congressional and legislative districts
- County board: commissioner districts
- City council: (wards) and precincts
- Township board: precincts
- School board: school election districts (if utilized)

County Commissioner District Requirements

County commissioner districts must be drawn to meet statutory requirements. These requirements influence the geography of the area the county commissioner districts cover. These requirements include:

- Each county is divided into as many districts as there are members of the board of commissioners,
- Commissioner districts are bounded by precinct lines (which may also correspond with town, municipal, and ward boundaries),
- Commissioner districts are composed of contiguous territory,
- Commissioner districts are to be as regular and compact in form as practicable, and
- District populations cannot vary more than ten percent from the average. (M.S. 375.025, subd. 1)

Nicollet County's Responsibilities

- Determine number of Commissioner Districts AND ensure that they meet the requirement of the goal population and within the 10%.
- Determine which districts will have to run for re-election and vary the terms for 2 year or 4 year.
 - District 2 & 4 up for 4 year election on regular schedule
- No plan will allow gerrymandering

- Public Open House will be held April 4, 2022 at the Nicollet County Board Government Center Board Room from 4:00 pm-6:00pm
- Public Hearing and County Board adopts redistricting plan at a Special Board Meeting April 19, 2022 at 9:00am.
- Send commissioner district maps and resolution to Secretary of State immediately following County Board adoption.
- May 3, 2022 Last day to publish new commissioner district lines
- May 10, 2022 Last day to appeal redistricting plan
- May 17, 2022 May 31, 2022 Early filing period for federal, state, and county positions






Nicollet County 2020 Census Populations - Option 1





Nicollet County 2020 Census Populations - Option 2





